	3. Technical Capability: Should have completed Similar works* completed in the last 3 years. Similar Works refers to Completion of works RCC/Masonry Boundary wall with Concertina Coil/Barbed wire fencing, Works related to Industrial/commercial/Pump House Buildings include major portion of RCC, Fabrication works & Construction of Road works.
