Financial Capacity: Average annual turnover in similar work for last three financial years (FY 17-18, 18-19 and 19-20) should be equal/higher than Rs. 27 Lakh3. Technical Capability: With a minimum of 3 years of experience in relevant business pertaining to the equipment / work range mentioned in the tender. The bidder shall have successfully completed at least 3 similar work of such characteristics in the last 5 years.
