2. निविदा और नियम एवं शर्तों पर संक्षिप्त जानकारी / Breif on tender and terms & conditions

2.1. सामान्य निर्देशः/General Instructions:

नेशनल ऑटोमोटिव टेस्ट ट्रैक्स (NATRAX) नेशनल ऑटोमोटिव बोर्ड (NAB) के तहत एक ऑटोमोटिव टेस्टिंग एंड सर्टिफिकेशन सेंटर है, जो भारी उद्योग मंत्रालय, भारत सरकार द्वारा गठित एक स्वायत्त निकाय है। NATRAX को लगभग 3000 एकड़ भूमि पर पीथमपुर, जिला धार, (मध्य प्रदेश, भारत) के पास, सभी प्रकार के ऑटोमोबाइल के व्यापक परीक्षण और मूल्यांकन के लिए स्थापित किया गया है।

National Automotive Test Tracks (NATRAX) is an Automotive Testing & Certification Centre under NATRIP Implementation Society (NATIS)/National Automotive Board (NAB) which is an autonomous body constituted by Ministry of Heavy Industries, Government of India. NATRAX has been set up on approx. 3000 acres of land for comprehensive testing and evaluation of all types of automobiles, near Pithampur, Dist. Dhar, (Madhya Pradesh, India).

NATRAX invited Bids/Quotations from experienced qualified and interested agencies /bidders for hiring of Group Medical Insurance and Group Personal Accident Insurance of NATRAX employees & dependents on the terms and conditions specified in this document.

2.2. आवश्यकताओं और कार्य के दायरे का विवरण:/Details of the requirements & scope of work:

- i. **कार्य का नाम:** प्रतिष्ठित TPAs / बीमा कंपनियों से "NATRAX, पीथमपुर, MP, के कर्मचारियों के लिए समूह मेडि-क्लेम बीमा पॉलिसी (GMP) और समूह व्यक्तिगत दुर्घटना नीति (GPA) के लिए "तृतीय-पक्ष प्रशासक (TPA) की नियुक्ति" के लिए निविदाएं।

Name of Work: "Engagement of Third-Party Administrator (TPA) for Group Medi-claim Insurance Policy (GMP) & Group Personal Accident Policy (GPA) for the Employees of NATRAX, Pithampur, MP"

- ii. **बोली प्रणाली:** दो बोली प्रणाली (तकनीकी और वित्तीय बोलियाँ अलग-अलग लिफाफों में प्रस्तुत की जानी हैं)।/ **Bid System:** Two bid system (Technical & Financial bids to be submitted in separate envelopes).





- iii. **बोली की वैधता:** बोली जमा करने की तारीख से 60 दिनों की अवधि के लिए वैध और स्वीकृति के लिए माननीय रहेगी/ **Bid Validity:** Bid shall remain valid and open for acceptance for a period of 60 days from the date of submission.
- iv. **अनुबंध अवधि:** कार्य एक वर्ष की अवधि के लिए प्रदान किया जाएगा और इसे पारस्परिक रूप से सहमत नियमों और शर्तों पर NATRAX से अनुमोदन पर आगे की अवधि के लिए बढ़ाया जा सकता है।/ **Contract Period:** The work shall be awarded for a period of one year and same may be extended for further period mutually on approval from NATRAX on mutual agreed terms and conditions.

2.3. अस्वीकरण/ Disclaimer:

- i. 2.4. न्यूनतम पात्रता मानदंड/ Minimum Eligibility Criteria

- iii. बोलीदाताओं को आईआरडीए, पैन और जीएसटी के साथ पंजीकृत होना चाहिए। संबंधित दस्तावेजों की प्रति प्रस्तुत की जानी चाहिए/ The bidders should be registered with IRDA, PAN and GST. Copy of the related documents should be submitted.
- iv. बोली लगाने वाले का कार्यालय इंदौर एवं दिल्ली/एनसीआर में होना चाहिए। संबंधित दस्तावेजों की प्रति प्रस्तुत की जानी चाहिए/ The bidder should have an office in Indore & Delhi/NCR. Copy of the related documents should be submitted.

Conditions for rejection of bids: Bids shall be rejected, if;

2.6. तकनीकी आवश्यकताएं/ Technical Requirements


I. **जीएमपी (ग्रुप मेडिक्लेम पॉलिसी): - कवर किए जाने वाले जीवन की सूची अनुबंध-ए संलग्न है/ GMP (Group Mediclaim Policy): - List of Lives to be covered is enclosed Annexure-A:**

(A) अस्पताल में भर्ती / रोगी लाभ/ Hospitalization/In-patient benefits - The insurance Scheme shall pay all expenses incurred in course of medical treatment availed of by the beneficiaries in an Empaneled Hospitals/Nursing Homes (with 24 hours admission clause) within the country, arising out of either illness/disease/injury and/or sickness. There shall be NO co-payment applicable. Room Rent for normal 1.5% of S.I. and for ICU 2% of S.I. without any monetary capping. (S.I.-Rs 7,50,000/10,00,000/12,50,000). Admission /Registration Charges to be covered without any sublimit. Congenital Internal Diseases, Seasonal Diseases, Lasik Treatment subject to agreed prescription of doctor with eye power of min. -/+7.5, to be covered, Ambulance charges upto Rs 4500/- per hospitalization. Disease wise Capping-No, except Cataract sublimit Rs 40,000/- per eye. Pre-hospitalization expenses within a period of 30 days shall also be included.

(B) पहले से मौजूद बीमारियों का कवरेज/ Coverage of Pre-existing diseases - All diseases under the Scheme shall be covered from day one. A person suffering from any disease/having implants & internal congenital disease prior to the inception of the policy shall also be covered.

(C) अस्पताल में भर्ती होने से पहले और बाद में लाभ/ Pre and Post hospitalization benefit - All expenses for the Pre hospitalization shall be 30 days and Post





Hospitalization period of upto 60 days would be covered required relating to the treatment of the sickness for which hospitalization was done.

(D) डे केयर प्रक्रियाएं/ Day Care Procedures - With the advances made in the treatment techniques, many medical treatments, formerly requiring hospitalization, can now be treated on a day care basis. The policy shall also provide for day care facilities (less than 24 hours hospitalization) for such identified procedures. Day care facilities shall be available for the treatments as per Annex-A.

NOTE: Bidder shall provide the exhaustive list of Day Care Procedures which shall cover all the procedures as per Annex-A

(E) प्रसूति-लाभ/ Maternity Benefit

- i) It shall cover treatment taken in Empaneled Hospital/Nursing Home arising from childbirth including Normal Delivery/Caesarean Section including miscarriage or abortion induced by accident or other medical emergency.
- ii) This benefit would be limited to only first two living children.
- iii) Limitation: Limited to Rs.45,000/- for Normal Delivery; Limited to Rs.75,000/- for Caesarean Delivery.

(F) नवजात लाभ/ Newborn Benefit

- i) Newborn child (single/twins) to an insured mother would be covered under the scheme from day one up to the expiry of the current policy for the expenses running incurred for treatment taken in empaneled Hospitals/Nursing Homes/Day Care Clinics as an in-patient during the same policy and will be treated as a part of the mother subject to eligibility of the Maternity Benefit as stated above.





- ii) If, in first pregnancy, twins are born then the benefit stand ceases for second pregnancy. However, in second pregnancy twins are born then both will be covered till the expiry of the running policy
- iii) Congenital diseases of new born child shall also be covered under this policy.

(G) बफर / कॉर्पोरेट फ्लोटर /Buffer /Corporate floater: For an amount of Rs. 15 Lakhs shall be there and it shall not be restricted to critical illness and can be utilized incase hospitalization expenses of a family exceed the Sum Insured amount, after the necessary approval / instruction from NATRAX authority.

(H) अन्य आवश्यकताएँ/ Other requirements:

- i) TPA: - One able representative who shall handle all the matters of our organization (24x7)
- ii) Pre hospitalization covered (30 days) and post hospitalization covered (60 days).
PAC Approval within 2 hrs. not beyond the limit.
- iii) Claim settlement Limit- a) for Reimbursement: -within 10 to 15 days and b) for Cashless: -same day.
- iv) Mid-term inclusion for dependents - New Born Baby or Newly Wedded Spouse (No Premium to be charged).
- v) Mid Term inclusion for New Employee with Dependents – Premium to be charged on pro rata basis.
- vi) List to be attached for all the covered items and not covered items and excluded expenses.
- vii) Detailed presentation of Benefits of policy and procedures for entitlement of claims by TPA / Representative of Insurance company is mandatory within 15 days of issuance of policy.

- ii) Eye operation: lens limit Rs 15000/- for each family.

- iv) Ayurveda medicine/ treatment cover in Mediclaim.
- v) Employee allow to increase the sum insurance amount; the difference of amount will be recovered from them.
- vi) **Half yearly health checkup of employee will be conducted under Mediclaim policy with below tests for each member covered under this policy.**
 - a. Complete Blood Count Profile (CBC)
 - b. Complete Lipid Profile
 - c. Complete LFT and KFT tests
 - d. ECG
 - e. Blood sugar fasting
 - f. ESR, Urine Routine
 - g. ABO Group & RH Type

The policy shall cover benefits under death, permanent / total disablement, permanent partial disablement and temporary total disablement. List shall be attached for all the covered items and not covered items and excluded expenses.


