

## **DETAILED SCOPE OF WORKS**

#### A. Introduction

The essential purpose of Towing winch mechanism is to guide and control vehicle at the specified speed and make sure that the hitting angle of vehicle is as perfect as possible. Winch also serve to signify, maintain specified speed of the vehicle, minimise the damage to the vehicle due to overturing after the release and ensure proper results of the crash barrier testing.

NATRAX is using the towing mechanism for conducting the road safety barrier testing, To avoid the failure, it is very important to set up a dedicated winch/pulling mechanism in the existing facility, which will pull the test vehicle and runs/guided through rail and rope system and release at specified point with emergency brake for the better accuracy of the system inside the NATRAX.

The National Automotive Test Tracks (NATRAX-Indore) is set up to be will be a world-class automotive proving ground on 2960 acres land for comprehensive testing and evaluation of all type of vehicles. The site is located between NH-3 and N-59 and well connected with road. The facility has all types of surface type to test vehicles against varying terrains and stringency. The large part of test load on this facility is related to evaluation of automotive performance such as max speed, acceleration, break, efficiency, noise, vibration, handling, stability etc. NATRAX will be the Centre of Excellence for Vehicle Dynamics. NATRAX wishes to obtain the design and specifications of a Mechanical/Electric winch mechanism for their crash barrier testing facility in its premises at Indore. Consultant is putting forth a proposal for preparing a DPR for the Mechanical/Electric winch mechanism for this crash barrier testing facility.

## Detailed scope of consultancy

Scope of work for Design and development of Winch, Rail & Rope Vehicle Guidance system for Crash Barrier Testing on Existing Acceleration Lane of General Road (T-16) of NATRAX,

- a) The consultants shall design Winch mechanism or Vehicle Guidance or pulling or Drive mechanism including design of Civil work (Grouting details of Rails and associated works), Mechanical work (Motors and system required), Electrical works and requirement, Rail & Rope drive system and automation system (if applicable) for testing up to TB61 i.e. 16,000 Kg. vehicles as per standard. The EN 1317 & MACH being referred for this testing.
- b) The consultants shall design the Rail & Rope vehicle guidance mechanism (Winch), which shall be capable to cater the Maximum speed limit up to 110Km/hour for the vehicle to be used in testing.





- c) The Consultant shall provide the suggestion/design/details of Platform and existing acceleration surface (General Road T-16) as per EN 1317 & MACH as applicable.
- d) The consultants shall define/design/detail a system, which shall be run through rope system on channel without any extended arm and also channelize the rope through the same Rail/Channel grouted on the existing Road surface.
- e) The consultant shall define/design/detail the vehicle pulling system which includes electric pulling system, power supply from the local network, frequency converter, electric motor steel cable and all rope rolls. it should absolutely be ensured that enough power is available spontaneously, different options. Optimum would be via the local power grid and its own transformer. Combine with Diesel power Units are also possible as well as all combinations, define demands on frequency converter, Define demands on electric motor with a nominal capacity.
- f) The consultant shall provide the design/details about Design of Emergency stop system: In case of a necessary abortion of the test, the brakes must be activated autonomously to prevent secondary collisions or collision risks.
- g) The consultants shall provide the design/details about efficient documentation of the various tests, utility requirements i.e. area will be equipped with electric wires for LAN, power supplies and trigger cables, including the design of electric boxes and their location at the Crash Barrier Testing site.
- h) Method statement for each system to be established for execution/fixing of Rail & Rope Guidance on the existing Bituminous surface/Road.
- i) Consultant to Ensure the Workability and Viability of Rail Rope Guidance system after execution of system.
- j) Provision of list of equipment's and services required to establish the Rail & Rope vehicle guidance system in all respect.
- k) Provision to extended the rail & Rope Vehicle Guidance system for future expansion if required.
- Supervision of consultant during the execution of work (based on need of NATRAX, to be quoted separately per visit)

#### Important specifications available at the site:

Following specification available at Existing Crash Barrier Testing site





- a) Acceleration Lane- Bituminous Road (Black Top) of 7.0M wide along with 1.0M earthen shoulder both side available at NATRAX, approx. length 2.2Km and connected with Crash Barrier Testing Platform. Acceleration lane with camber on both sides from Centre and the gradient from start point to platform is varying from 0.00% to 0.784% in various stretch of 2.2Km
- b) Crash Barrier Testing Platform- Murrum Platform of 120mx15m available to install the testing crash barrier.
- c) *Expansion availability-* Area available for expansion on both sides of acceleration lane and after crash barrier testing platform
- d) Proposed winch arrangement (Rail & Rope or Vehicle guidance system)-shall be designed upto 500m length and it is also extendable if require in future (consultants deign and modify the length as per requirements).

# Proposed Activities to be carried out by consultants

- a) Preparation of DPIR along with Bill of Quantity, Technical Specification, design report, drawings etc.
- b) Drawings shall be prepared/provided for every aspect/step of work for winch arrangements or vehicle guidance system, this includes Civil, Electrical, Mechanical system and utility drawings as applicable.
- c) Preparation and provision of Design report of Civil, Electrical, Mechanical system for winch arrangements of rope and/or vehicle pulling guidance system, including specified pulling capacity at mentioned speed as per the applicable Indian/international standard
- d) Design and specification of items for vehicle Drive/guidance System.
- e) Preliminary design and specification of items for Emergency stop system
- f) Design report and item specification for cabling/wiring for test infrastructure.
- g) Preparation of tender documents for tendering purpose and submission of probable agencies to have similar nature of work experience.
- h) Site Visit by consultant during the course of execution of work after tender process at least 2-3 visit is required.

## Deliverables by consultant

The Detailed Project Information Report (DPR) include the followings:

1) Modification or improvement in existing area on site and optimum arrangement of the





facility.

- 2) Drawings with respect to General overview, Asphalt work, Foundations for rails/ropes, Foundations for motors, Rope course, Foundations for guidance systems, Foundations for rope wheels, Foundations for add on testing (e.g. different suggested barrier foundations) and requisite GFCD's to execute the works in all respect.
- 3) Drawings and Definition of the demands of the mechanical winch system and its control system: Control computer for the rope, Software for the control of the system, Rope tensioning system, all rope rolls including mountings.
- 4) Drawing and design details of the emergency stop system.
- 5) Test infrastructure wiring: Assist design, Provision of drawings on request if any change occur, provide equipment lists, modified drawings if required.
- 6) design report of the vehicle guidance system along with calculation.
- 7) Vetting and validation of systems after execution of works as per the Indian/international standard as applicable.

#### **Timelines**

Consultant is recommended to submit the draft DPIR for client review within 6 weeks from issuance of Work order. Final DPIR shall be provided after correction in draft DPIR within 2 weeks from the date of correction along with all deliverables, drawings, details and design report.

These details are provided for giving additional information to the Bidders and for reference purpose only.

#### SPECIAL CONDITIONS OF CONTRACT

# GENERAL MINIMUM ELEGIBILITY CRITERIA

The bidder shall satisfy the following minimum eligibility criteria to participate in the Tender.

- (a) Should have combined turnover of at least INR 1.0 Crore (INR 10 Million) from the business or from the consultancy works, during last 3 financial years (2019-20, 2020-21 & 2021-22).
- (b) Experience of more than 5 years as Main Consultant/Lead Member in a Consortium. Expertise in the field of Consultancy for Execution, Development, supply/installation of winch/pulling mechanism/vehicle guidance system for Safety Barrier restraint testing. The bidder is required to furnish the relevant proof.

## Bidder need to submit all relevant documents sought in "Bidding forms"

- The Bidder shall necessarily be a legally valid entity either in the form of Proprietary firm, Partnership firm, Private Limited Company or a consortium of several firms.
- The Bidders are expected to carefully examine all the contents of the tender documents including instructions, conditions, terms, specifications and drawings and take them fully into account before submitting their offer. Failure to comply with the requirements as detailed in these documents shall be at the Bidder's own risk. Bidders which are not responsive to the requirements of the tender documents will be rejected.
- While all efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- The tender prepared by the Bidder and all correspondence and documents relating to the tender, exchanged between the Bidder and NATRAX shall be in the English language.

Each page of the Tender documents should be stamped and signed by the person or persons submitting the Tender in token of his/their having acquainted himself/themselves with the tender documents. Any Tender with any of the Documents not so signed is liable to be rejected at the discretion of NATRAX.

The Bid submitted on behalf of a Firm shall be signed by all the partners of the Firm or by a Partner who has the necessary authority on behalf of the Firm to enter into the proposed contract. Otherwise, the Tender may be rejected by the NATRAX.



The bidder who has been black listed or terminated by any of the Govt. Bodies shall not participate in the bidding process. Incase found at any stage latter NATRAX reserve the rights to terminate the contract without prior notice.

The Consultant shall design/validate all the utilities works as defined in scope of works at relevant Item of detailed scope of works (DSW) and as per instructions of NATRAX or NATRAX's authorised representative. If in the opinion of NATRAX, changes have to be made in the design and it desires the consultant to carry out the same. The decision of NATRAX in such cases shall be final and shall not be open to arbitration.

The Bidder must obtain for himself on his own responsibility and at his own expenses all the information which may be necessary for the purpose of making a bid and for entering into a contract, must examine the Scope of works, may inspect the sites of the work, if they so desire, acquaint himself with all local conditions, means of access to the work, nature of the work and all matters pertaining thereto on its own expenses or seek clarifications from NATRAX.

The successful Bidder shall co-ordinate with the NATRAX representative and other consultant, equipment suppliers appointed by NATRAX to ensure that the work proceeds smoothly without delay as and when required as per instructions of NATRAX and to ensure this, one design co-coordinator is required to be placed at NATRAX HQ.

The successful bidder shall have capacity and will be required to take up the utilities design work based on the priorities and timelines given by the NATRAX for more than one location simultaneously.

The NATRAX reserves the right to split up the works and award these to more than one consultant to complete the design project within the desired time.

The NATRAX reserves the right to increase / decrease quantum of any/all works under the detailed scope of works and not to operate any/all the items in the scope of works. NATRAX also reserves right to change the scope of works, resulting in operating any additional scope of works and in such cases, the rates and the completion time shall be mutually agreed. Any increase in the original total value shall liable the consultant to suitably modify the value of the PBG.

The work shall be carried out strictly in accordance with the Preliminary specifications & information given by NATRAX and also in compliance of the requirements of the Indian/International standards/ International best practices and also in compliance of regulatory authorities/local bodies and no deviation on any account will be permitted. Any amendments resulting out of the comments from local /regulatory authorities should be incorporated without any extra cost. The documentation required for obtaining

statutory approvals will be consultant's scope, however the action for obtaining the approvals is in NATRAX's scope.

The successful Bidder shall enter into contract and duly sign an Agreement within thirty (15) days from the date of issue of Letter of Acceptance (LoA). The LoA issued by NATRAX to the Bidder will constitute a binding to the Contract between NATRAX and the person so tendering, whether such formal agreement is not subsequently executed. The successful Bidder shall accept the LoA within three (3) days from the date of issue of such letter.

The bid price of the successful bidder shall be valid for 12 months from the date of issue of Letter of Acceptance (LoA)

#### AMENDMENT TO TENDER DOCUMENT

Addendum / Corrigendum to the tender document may be issued prior to the date of opening of the Bids to bring certain/necessary clarify to the tender documents or to incorporate any modifications, insertions, deletions etc. All such addendum / corrigendum shall be treated as an integral part of the tender.

In order to afford prospective bidders, reasonable time for preparing their tenders after taking into account such amendments, NATRAX may, at its discretion, extend the deadline for submission of tenders.

#### PROCESS TO BE CONFIDENTIAL

Except the public opening of Bids, information relating to the examination, clarification, evaluation and comparison of tenders and recommendations concerning the award of Contract shall not be disclosed to Bidders or other persons not officially concerned with such process.

Any effort by a Bidder to influence NATRAX or any of its functionaries in the process of examination, clarification, evaluation and comparison of tenders and in decisions concerning award of contract, may result in the rejection of the Bid.

As part of his Technical Bid, the Bidder shall be required to furnish an undertaking for confidentiality as "Letter of Undertaking".

#### NATRAX'S RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDDERS

#### 9. BID OPENING AND EVALUATION PROCESS

#### 9.1. Techno-Commercial Bids Opening

- 9.1.1. The Techno-Commercial Bid shall be opened on **the specified date** at the Corporate Office of NATRAX in the presence of the Bidders or their duly authorised representatives who choose to remain present at the time of opening of Bids.
- 9.1.2. The sealed Techno-Commercial bid envelop shall be opened in the presence of Bidders or their duly authorized representatives at the time mentioned above, in the presence of the members of NATRAX's bid opening Committee.
- 9.1.3. A letter of authorization by the Bidder's representative shall be submitted at the NATRAX Corporate Office at the time of opening of Bids.
- 9.1.4. Absence of Bidders or their duly authorized representatives shall not impair the legality of the bid opening process.

- 9.1.5. All Bidders or their duly authorized representatives present shall be required to sign the main bid envelopes by way of confirmation of sealed bid status at the time of opening of bids.
- 9.1.6. After identification signing, the NATRAX's Bid opening committee representative shall open the main bid envelope. After opening, Bidders or their duly authorized representatives shall be required to sign the Techno-Commercial and financial bid envelopes of all the Bidders.

- 9.2.3. Not furnishing an Affidavit in the format as in Form-j regarding 'no conviction' and 'no conflict of interest'.

9.2.4. Debarred/ blacklisted by any of the Departments of Government of India, State Government, Public Sector Undertaking, Local Bodies of India or Foreign Governments.

#### 9.3. Techno-Commercial Bid Evaluation

- 9.3.1. The valid Bids which meet the Minimum eligibility Criteria as per Para 6.2 of Annexure I shall be further evaluated.
- 9.3.2. NATRAX shall follow the **Integrated Bid Evaluation** and the combined score of Techno-Commercial and Financial bids mentioned at Para 9.5 will determine the Successful Bidder.
- 9.3.3. During the Techno-Commercial bid evaluation process, NATRAX may seek clarifications from the bidder through E-mail/ Fax, for confirming and consolidating their Techno-Commercial offers.
- 9.3.4. All such clarifications are required to be answered by the bidder by Email/ Fax, within the time specified by NATRAX. The signed hard copies of the same need to be submitted to NATRAX and shall be deemed to be a part of the EOI Documents.
- 9.3.5. All valid bids shall be examined against the criteria as specified in "Evaluation Parameters".
- 9.3.6. The valid bidders would be required to demonstrate their credentials before a High Level Committee (HLC) constituted by Competent Authority through a presentation to be made at a date, time and venue decided by NATRAX. The scoring shall be done by the Members of the HLC against the Evaluation Parameters specified under Para 18.1.3.
- 9.3.7. Such bids which qualify the minimum criteria as per Para 18.1.2 shall be intimated regarding opening of financial bid, with at least 6 days of prior notice in writing, or a lesser period with mutual agreement with the respective bidders intimated over telephone/email/fax by NATRAX.

#### 9.4. Financial Bids Opening

9.5.1. All valid financial bids shall be evaluated/ scrutinized as per "Evaluation Parameters"

#### 9.6. Integrated Bid System:

9.6.1. Evaluation will be done by adopting Integrated Bid System (Combined Quality cum Cost Based System) as under:-

The marks scored by the short-listed bidders in the Techno-Commercial evaluation will be given a weightage of 70, while the financial bids of the techno-commercially qualified bidders will be given a weightage of 30. For Financial evaluation, the total cost indicated in the Financial Bids will be considered. The lowest financial Bid (FM) will be given financial scores (SF) of 100 points. The financial scores of other Bids will be computed as follows:-

SF = 100x FM / F

(F= amount of Financial Proposal)

The proposal will finally be ranked according to their combined Techno-Commercial (ST) and financial (SF) scores as follows:-

S = ST \* Tw + SF \* Fw

Where, Tw and Fw are weights assigned to Techno-Commercial and financial Proposals that shall be 0.70 and 0.30 respectively.

The combined score of Techno-Commercial and financial bids will determine the final rank.

9.6.2. The Bidder scoring the highest points/marks (H1) based on the above system would be selected as the Successful Bidder.

9.6.3. It is reiterated that NATRAX does not undertake to accept any bid, in all the above cases as mentioned in the clause 1.6 of the Disclaimer.

- **10.3.** If the financial bid is unbalanced, front loaded or substantially in variance with the updated estimates in the opinion of NATRAX, NATRAX may require the successful bidder to produce detailed price analyses for any or all items of the Financial Bid, to demonstrate the internal consistency of those prices with the market price and schedule proposed.
- **10.4.** Negotiations will conclude with a revised offer letter from the successful bidder.

#### 11. NATIS's RIGHT TO REJECT ANY OR ALL BIDS

- **11.1.** NATRAX reserves the right to accept or reject any bid, and to annul the EOI process and reject all Bids, at any time prior to award of Contract without assigning any reasons for such acceptance/ rejection, or to divide the Contract between/amongst Bidders without thereby incurring any liability to the affected Bidder or Bidders or any obligations to inform the affected Bidder or Bidders of the grounds for NATRAX's action. The Bidders shall not have any cause of action or claim against NATRAX for rejection of their bids.
- **11.2.** NATRAX reserves the right to, without limitation, without incurring any obligation or liability vis-à-vis any Bidder and without expressing any cause or reason thereof, at any time and at its sole discretion amend or supplement the EOI Document and/or the selection process or the dates or other terms and conditions relating thereto, suspend and/or cancel the selection process.
- **11.3.** NATRAX reserves the right to, without limitation, without incurring any obligation or liability vis-à-vis any Bidder and without expressing any cause or reason thereof, at any time and at its sole discretion to independently disqualify, reject and/or accept any and all Bids or other information and/or evidence submitted by or on behalf of any Bidder, including without limitation pursuant to and/or in connection with receipt of a Bid after the submission deadline and/or determination that a Bidder will be unable to fulfil the requirements of the EOI Document.
- **11.4.** The decisions and/or the exercise of discretion by NATRAX shall not be challenged by any Bidder and are final.
- **11.5.** Any failure by NATRAX to exercise any rights hereunder, pursuant hereto and/or in connection herewith, shall not be a waiver of those or any other rights unless expressly stated as such in writing by NATIS.

**11.6.** The Bidders and their respective officers, employees, agents and advisers must not engage in any collusive bidding, anti-competitive conduct or any other similar conduct with any other Bidder or any other entity in relation to the preparation or lodgement of Bids or otherwise in any aspect of the Works.

#### 12. NOTIFICATION OF AWARD

- **12.1.** Prior to the expiry of the period of Bid validity prescribed, NATRAX will issue to the Successful Bidder, the "Letter of Acceptance" (LOA) in duplicate. The Successful Bidder shall return one copy of the Letter of Acceptance to NATRAX duly acknowledged and signed by the authorized signatory, within seven [7] days of receipt of the same by him.
- **12.2.** The Letter of Acceptance shall constitute a part of the Contract.
- **12.3.** Time being the essence of the Contract, timelines/ schedule mentioned in Para 6.5 of Terms of Reference are sacrosanct and will kick-in from the date of issue of the LOA. Hence, Work may be commenced immediately after issuance of the LOA.
- **12.4.** After the execution of "The Contract agreement" with the Successful Bidder/Consultant (Transaction Advisor), NATRAX will promptly notify all the unsuccessful Bidders and discharge/ return their Earnest Money Deposit.
- **12.5.** No correspondence will be entertained by NATRAX from the unsuccessful Bidders.

#### 13. SIGNING OF CONTRACT.

- **13.1.** The Consultant (Transaction Advisor) shall enter into and duly sign the Contract for performance, execution and implementation of the works as mentioned in EOI document within **thirty [30] days** from the date of issue of letter of acceptance. But the written acceptance LOA by NATRAX of a Bid will constitute a binding Contract between NATRAX and the entity so bidding, whether such formal agreement is not subsequently executed.
- **13.2.** Upon receipt of the Performance Bank Guarantee, NATRAX shall prepare the Contract Agreement in two copies, duly incorporating all the terms of agreement between the two parties and send the same in duplicate to the Consultant (Transaction Advisor) within **Twenty one** [21] days of the date of receipt of the "Letter of Acceptance" duly acknowledged and signed by the Consultant (Transaction Advisor).

#### 14. NON-EXCLUSIVITY

The rights of the Consultant (Transaction Advisor) to perform, execute and implement the Works or any part thereof pursuant to the Contract, is not exclusive and shall not prevent NATRAX from granting a similar right to other parties.

#### 15. PROCESS TO BE CONFIDENTIAL

- **15.1.** Except the public opening of Bids, information relating to the examination, clarification, evaluation and comparison of Bids and recommendations concerning the award of Contract shall not be disclosed to Bidders or any other persons.
- **15.2.** Any effort by a Bidder to influence NATRAX or any of its functionaries in the process of examination, clarification, evaluation and comparison of EOIs and in decisions concerning award of contract, may result in the rejection of the Bid.
- **15.3.** As part of their Techno-Commercial Bid, the Bidder shall be required to furnish an undertaking for confidentiality as "Form (b) Letter of Undertaking".

#### 16. PERFORMANCE BANK GUARANTEE

- **16.1.** Within **fifteen** [15] days of the date of acceptance of the LoA, the Consultant (Transaction Advisor) shall execute a Performance Bank Guarantee as per the Form (c), from a scheduled Bank, for an amount equivalent to the 10% of the contract value, which shall be kept valid for six (6) month after the period of execution of Work. The PBG shall be made in INR/EURO/USD only.
- **16.2.** The Performance Bank Guarantee of the Consultant (Transaction Advisor) will be invoked and forfeited if the Consultant (Transaction Advisor) fails to comply with the terms of Contract.

#### 17. TERMS OF PAYMENT

The terms of payment shall be as described in para 6.3 of Terms of Reference (Annexure I).

#### 18.2. Evaluation Parameters for Financial Bids:

- 18.2.1. The Financial Bids of all the Techno-Commercially qualified Bidders shall be opened and evaluated.
- 18.2.2. For the evaluation of the Financial Bids, the eventual Bid prices shall be ascertained after considering all the terms and conditions associated with the Bid price specified in the Financial Bid document. NATRAX reserves the right to include or exclude any component of the price quoted by the Bidder and / or load the bid price as per its discretion to work out the Bid Price for evaluation.
- 18.2.3. If there is a discrepancy between the sub total/s and the total price that is obtained by multiplying the unit price and quantity/adding the sub total/s, the sub total/s shall prevail and the total price shall be corrected, unless in the opinion of NATRAX that there is an obvious misplacement of the decimal point in the sub total price, in which case the total price as quoted shall govern and the sub total/s shall be corrected;

## Consultancy Proposal for Development winch/pulling mechanism for Safrt Barrier restraint testing.

#### A. Introduction

The essential purpose of Towing winch mechanism is to guide and control vehicle at the specified speed and make sure that the hitting angle of vehicle is as perfect as possible. Winch also serve to signify, maintain specified speed of the vehicle, minimise the damage to the vehicle due to overturing after the release and ensure proper results of the crash barrier testing.

NATRAX is using the towing mechanism for conducting the road safety barrier testing, To avoid the failure, it is very importants to set up a dedicated winch/pulling mechanism in the existing facility, which will pull the test vehicle and runs/guided through rail and rope system and release at specified point with emergency brake for the better accuracy of the system inside the NATRAX.

The National Automotive Test Tracks (NATRAX-Indore) is set up to be will be a world-class automotive proving ground on 2960 acres land for comprehensive testing and evaluation of all type of vehicles. The site is located between NH-3 and N-59 and well connected with road. The facility has all types of surface type to test vehicles against varying terrains and stringency. The large part of test load on this facility is related to evaluation of automotive performance such as max speed, acceleration, break, efficiency, noise, vibration, handling, stability etc. NATRAX will be the Centre of Excellence for Vehicle Dynamics. NATRAX wishes to obtain the design and specifications of a Mechanical/Electric winch mechanism for their crash barrier testing facility in its premises at Indore. Consultant is putting forth a proposal for preparing a DPR for the Mechanical/Electric winch mechanism for this crash barrier testing facility.

#### B. Expected scope of consultant

Scope of work for Design and development of Winch, Rail & Rope Vehicle Guidance system for Crash Barrier Testing on Existing Acceleration Lane of NATRAX,

a) The consultants shall design Winch mechanism /Vehicle Guidance/ pulling/Drive mechanism including design of Civil work (Grouting details of Rails and associated works), Mechanical work (Motors and system required), Electrical works and requirement, Rail & Rope drive system and automation

- system (if applicable) for testing up to TB61 i.e. 16,000 Kg. vehicles as per standard. The EN 1317 & MACH being referred for this testing.
- b) The consultants shall design the the Rail & Rope vehicle guidance mechanism (Winch), which shall be capable to cater the Maximum speed limit up to 110Km/hour for the vehicle to be used in testing.
- c) The Consultsnts shall provide the suggestion/design/details of Platform and exsiting acceleration surface as per EN 1317 & MACH as applicable.

Combine with Diesel power Units are also possible as well as all combinations, Define demands on frequency converter, Define demands on electric motor with a nominal capacity.
- f) The consultsnt shall provide the design/details about Design of Emergency stop system: In case of a necessary abortion of the test, the brakes must be activated autonomously to prevent secondary collisions or collision risks.
