1. General

3. Minimum Eligibility Criteria (MEC):

The MEC of the limited tender could be as under:

I. Legal valid entity

(NATRA)

- i. Firm Registration certificate
- ii. PF & ESIC registration of Madhya Pradesh
- iii. GST registration
- II. Annual Turnover Average annual turnover for last 3 Financial Years (FY) should not be less than 15 lakhs, copy of CA Certificate OR audited balance sheet (with UDIN No.) should be enclosed.
- III. Work Experience- (Copy of work order or completion certificate in last 3 Financial Years (FY))-
 - Minimum 1 order from Government organizations / reputed private companies located in Pithampur / Dhar/Mhow for labour supply for 80% of the estimate value OR
 - Minimum 2 orders from Government organizations / reputed private companies located in Pithampur / Dhar/ Mhow for labour supply for 50% of the estimate value OR
 - Minimum 3 orders from Government organizations / reputed private companies located in Pithampur / Dhar/ Mhow for labour supply for 40% of the estimate value

The documents in support of above MECs shall be mandatory to be attached with the quotation.

IV. Bidder should have office in Pithampur/Dhar/ Mhow only.

Bidder to mandatorily submit all above documents in proof sr. no. I to IV above failing which bidder will not be evaluated further.

Billders are reped to use the format given in this document for quoting the rates.

4. Terms and conditions

- i. Scope of work: Providing Manpower/labour services as and when required at NATRAX, ON DAILY BASIS OR MONTHLY BASIS.
- ii. Payment: The Payment of the actual utilization of labour shall be released on completion of respective month and submission of original invoice with all supporting documents like PF deposited slip, ESI deposited slip etc, within 15 days from the date of submission of details as above.
 - The GST shall be reimbursed on actual basis.
- iii. Validity of contract: the contract shall be valid for 3 months from the date of start (however the deployment of labour shall be purely on as and when required basis).
- iv. Requirement: the service provider should undertake to provide the labour as and when required on per day minimum wages basis.
- v. Labour rates: the rates of labour should be based on central minimum wages act including PF, ESI, over & above these minimum charges the agency should quote their rates. The quoted amount against the tender should be inclusive of GST/Taxes.
